Cancellation penalties will be applied without exception unless you purchase the Penalty Waiver, Spirit Vacations penalties are in addition to any supplier penalties and are subject to change at any time. As an added bonus, if the advertised price of your particular vacation, with the same room category and same features (including air class of service) increases or decreases for your specific departure date or flight, you will be guaranteed the lowest available price advertised by Spirit Vacations. You may receive the lowest available advertised price on an identical vacation by providing written verification of the lower price to Spirit Vacations. In order to secure the lowest advertised price, your vacation must be rebooked to reflect the new rate prior to departure.

All cancellations must be confirmed by Spirit Vacations' reservations department prior to departure. This penalty waiver does not apply to "NO-SHOW" situations where you do not check-in or to denied-boarding situations, nor will it waive revision fees.

Note: When a cancellation is made, all refunds will be given in the original form of payment, less the price of the waiver, non-refundable scheduled air tickets and scheduled airline cancel/re-ticketing fees. This waiver does not cover non-refundable scheduled air tickets. However, if cancellation is received a minimum of three (3) days prior to the departure date, the value of re-useable air tickets may be applied to a future Spirit Vacations scheduled air booking for the cost of the airline re-ticketing fee. Bookings for future travel must be made at the time of cancellation. Increases in the scheduled air price of rebooked vacations are the responsibility of the traveler. Published fares are always non-refundable. If the number of individuals occupying a room decreases, the remaining travelers will be responsible for additional costs incurred as a result of a change in the per person occupancy rate. The Penalty Waiver must be purchased at the time of booking and may not be added at a later date.
